With eSignature, you can review documents and sign them from your computer, which is why the capability is sometimes referred to as a “digital signature.” Your data is safe. Your personal information is secure. The process is both convenient and efficient.

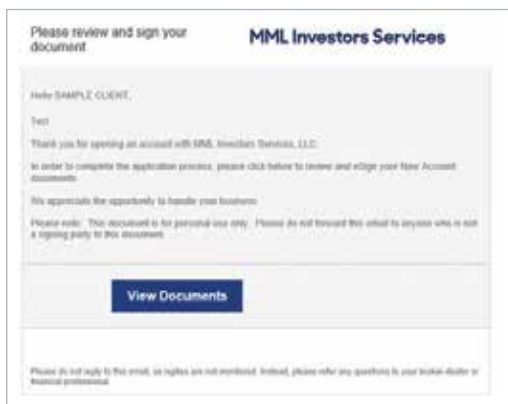
Following is an overview of the **easy four-step process** to establishing eSignature for your brokerage accounts.



Step 1:

Invitation

You'll receive an email from **dse@docusign.net** that includes a link to the documents required for opening your account. When you **click on the link**, you will access a secure website designed to protect your personal information and facilitate the opening of your account.



This **invitation expires in 30 days**, so please act promptly.

If there are multiple owners of the new account, each will receive an invitation.

eSignature is available only for clients who have an e-mail address that is unique to them. You cannot use another person's e-mail address to initiate the process. If you do not have an e-mail address, your financial service professional will have you complete a paper application.

You can revert to a paper process at any time. Simply print the forms and sign them.

Step 2:

Authenticate Your Identity

One way we maintain client confidentiality is by asking you to **verify your identity** before allowing you access to the documents.

The system will prompt you to either answer a series of systematically-generated knowledge-based questions, or provide the authorization code given to you by your financial professional.

Step 3:

Review, Sign and Provide Additional Documentation

Once your identity is authenticated, the documents will be accessible for **review and signature**. From there, you will receive instructions for reviewing and signing documents. You can scroll through the account documents at your own pace.



You will be prompted to **sign the documents** by adopting a signature, or if you are accessing the documents using a compatible mobile device, you can choose to sign your name using your finger or a stylus.



Step 4:

Submit Your Signature

Confirm completion of the review process by **finalizing your signature.**



Once the eSignature is complete and all parties have signed the account opening documents, you will receive a final e-mail with access to all fully executed documents. You may choose to save or print all documents and store them away for future reference.
